**1. Objective**

The objective of these Regulations is to extend the operation of the Police (Charges) Regulations 1992<sup>1</sup> for the period specified in regulation 3.

**2. Authorising provisions**

These Regulations are made under sections 5 and 28 of the **Subordinate Legislation Act 1994**.

**3. Extension of operation**

The operation of the Police (Charges) Regulations 1992 is extended for the period beginning on the day on which they would otherwise be revoked by virtue of section 5 of the **Subordinate Legislation Act 1994** and ending on 31 January 2004.

The Subordinate Legislation (Police (Charges) Regulations 1992 - Extension of Operation) Regulations 2003, S.R. No. 5/2003 were made on 22 January 2003 by the Governor in Council under sections 5 and 28 of the **Subordinate Legislation Act 1994**, No. 104/1994 and came into operation on 22 January 2003.

The Subordinate Legislation (Police (Charges) Regulations 1992 - Extension of Operation) Regulations 2003 will sunset 10 years after the day of making on 22 January 2013 (see section 5 of the **Subordinate Legislation Act 1994**).
