**1. Objective**

The objective of these Regulations is to extend the operation of the Park Regulations 1992<sup>1</sup> for the period specified in regulation 3.

**2. Authorising provisions**

These Regulations are made under sections 5 and 28 of the **Subordinate Legislation Act 1994**.

**3. Extension of operation**

The operation of the Park Regulations 1992 is extended for the period beginning on the day on which they would otherwise be revoked by virtue of section 5 of the **Subordinate Legislation Act 1994** and ending on 29 June 2003.

The Subordinate Legislation (Park Regulations 1992 - Extension of Operation) Regulations 2002, S.R. No. 30/2002 were made on 30 April 2002 by the Governor in Council, on the certificate and recommendation of the Minister for Environment and Conservation, under sections 5 and 28 of the **Subordinate Legislation Act 1994**, No. 104/1994 and came into operation on 30 April 2002.

The Subordinate Legislation (Park Regulations 1992 - Extension of Operation) Regulations 2002 will sunset 10 years after the day of making on 30 April 2012 (see section 5 of the **Subordinate Legislation Act 1994**).
