1. Objective

The objective of these Regulations is to extend the operation of the Zoological Parks and Gardens (Administration) Regulations 1992¹ for the period specified in regulation 3.

2. Authorising provisions

These Regulations are made under sections 5 and 28 of the **Subordinate Legislation Act 1994**.

3. Extension of operation

The operation of the Zoological Parks and Gardens (Administration) Regulations 1992 is extended for the period beginning on the day on which they would otherwise be revoked by virtue of section 5 of the **Subordinate Legislation Act 1994** and ending on 16 November 2003.

The Subordinate Legislation (Zoological Parks and Gardens (Administration) Regulations 1992 - Extension of Operation) Regulations 2002, S.R. No. 93/2002 were made on 1 October 2002 by the Governor in Council under sections 5 and 28 of the **Subordinate Legislation Act 1994**, No. 104/1994 and came into operation on 1 October 2002.

The Subordinate Legislation (Zoological Parks and Gardens (Administration) Regulations 1992 - Extension of Operation) Regulations 2002 will sunset 10 years after the day of making on 1 October 2012 (see section 5 of the **Subordinate Legislation Act 1994**).
