1 Objective

The objective of these Regulations is to extend the operation of the Health Services (Residential Services) Visitors Board Elections Regulations 2002, which would otherwise be revoked by virtue of section 5(1) of the **Subordinate Legislation Act 1994**, for the period specified in regulation 3.

2 Authorising provisions

These Regulations are made under sections 5A and 28 of the **Subordinate Legislation Act 1994**.

3 Extension of operation

The operation of the Health Services (Residential Services) Visitors Board Elections Regulations 2002¹ is extended for the period beginning on 5 March 2012 and ending on 30 June 2012.

4 Expiry

These Regulations expire on 1 July 2012.
