1 Objective

The objective of these Regulations is to extend the operation of the Trustee Companies Regulations 1995 for the period specified in regulation 3.

2 Authorising provisions

These Regulations are made under sections 5 and 28 of the **Subordinate Legislation Act 1994**.

3 Extension of operation

The operation of the Trustee Companies Regulations 1995¹ is extended for the period beginning on the day on which they would otherwise be revoked by virtue of section 5 of the **Subordinate Legislation Act 1994** and ending on 3 April 2006.

The Subordinate Legislation (Trustee Companies Regulations 1995 - Extension of Operation) Regulations 2005, S.R. No. 14/2005 were made on 30 March 2005 by the Governor in Council, on the certificate and recommendation of the Treasurer and Minister for Consumer Affairs, under sections 5 and 28 of the **Subordinate Legislation Act 1994**, No. 104/1994 and came into operation on 30 March 2005.

The Subordinate Legislation (Trustee Companies Regulations 1995 - Extension of Operation) Regulations 2005 will sunset 10 years after the day of making on 30 March 2015 (see section 5 of the **Subordinate Legislation Act 1994**).
