1 Objective

The objective of these Regulations is to prescribe the form of notice of execution of a search warrant to be given under section 342(6) of the **Crimes Act 1958**.

2 Authorising provision

These Regulations are made under section 345 of the **Crimes Act 1958**.

3 Revocation

The Crimes (Extra-Territorial Offences) Regulations 1999¹ are **revoked**.

4 Form

A notice under section 342(6) of the **Crimes Act 1958** must be in the form set out in the Schedule.

The Crimes (Extra-Territorial Offences) Regulations 2009, S.R. No. 65/2009 were made on 10 June 2009 by the Governor in Council under section 345 of the **Crimes Act 1958**, No. 6231/1958 and came into operation on 10 June 2009.

The Crimes (Extra-Territorial Offences) Regulations 2009 will sunset 10 years after the day of making on 10 June 2019 (see section 5 of the **Subordinate Legislation Act 1994**).
