Forests (Tour Operator Licence Fee) Amendment Regulations 2018

1 Objective

The objective of these Regulations is to amend the Forests (Tour Operator Licence Fee) Regulations 2011 to reflect amendments made to the **Forests Act 1958** by the **Parks Victoria Act 2018**.

2 Authorising provision

These Regulations are made under section 100A of the **Forests Act 1958**.

3 Commencement

These Regulations come into operation on 12 September 2018.

4 Principal Regulations

In these Regulations, the Forests (Tour Operator Licence Fee) Regulations 2011¹ are called the Principal Regulations.

5 Definitions

In regulation 4 of the Principal Regulations, in the definition of *use fee*, for "Secretary" **substitute** "land manager".

6 Use fee for a standard licence

In regulation 8(1) of the Principal Regulations, for "Secretary" **substitute** "land manager".

7 Use fee form

In regulation 11(2)(c) of the Principal Regulations, for "Secretary" **substitute** "land manager".

8 Application of Part

In regulation 12 of the Principal Regulations, for "Secretary" **substitute** "land manager".

9 Annual licence fees for competitively allocated licence

In regulation 14(1)(a) and (2) of the Principal Regulations, for "Secretary" **substitute** "land manager".

10 Use fee for a competitively allocated licence

In regulation 15(1) of the Principal Regulations, for "Secretary" **substitute** "land manager".

11 Use fee form

In regulation 16(2)(c) of the Principal Regulations, for "Secretary" **substitute** "land manager".

12 Reduction, waiver or refund of licence fees

(1) In regulation 17(1) and (4) of the Principal Regulations, for "Secretary" **substitute** "land manager".

- (2) In regulation 17(3) of the Principal Regulations,
for "the Secretary, on his or her own motion,"
substitute "the land manager, on the land
manager's own motion,".

13 Surrender of licence

In regulation 19 of the Principal Regulations,
for "Secretary" **substitute** "land manager".
