1 Objective

The objective of these Regulations is to prescribe certain persons and bodies as public bodies for the purposes of the **Audit Act 1994**.

2 Authorising provision

These Regulations are made under section 21 of the **Audit Act 1994**.

3 Commencement

These Regulations come into operation on 27 June 2015.

4 Revocation

The following Regulations are **revoked**—

- (a) the Audit (Public Bodies) Regulations 2005¹;
- (b) the Audit (Public Bodies) (Amendment) Regulations 2007².

5 Public bodies

Each person or body listed in Schedule 1 is prescribed as a public body for the purposes of the definition of *public body* in section 3(1) of the **Audit Act 1994**.

The Audit (Public Bodies) Regulations 2015, S.R. No. 63/2015 were made on 16 June 2015 by the Administrator of the State of Victoria, as the Governor's deputy, with the advice of the Executive Council under section 21 of the **Audit Act 1994**, No. 2/1994 and came into operation on 27 June 2015: regulation 3.

The Audit (Public Bodies) Regulations 2015 will sunset 10 years after the day of making on 16 June 2025 (see section 5 of the **Subordinate Legislation Act 1994**).
