Introduced in the Assembly

Legislation Reform (Repeals No. 4) Bill 2009

A Bill for an Act to repeal certain spent Acts relating to land.

The Parliament of Victoria enacts:

1 Purpose

The main purpose of this Act is to repeal spent Acts relating to land.

2 Commencement

This Act comes into operation on the day after the day on which it receives the Royal Assent.

3 Repeal of Acts

The Acts listed in the Schedule are **repealed**.

4 Repeal of repealing Act

This Act is **repealed** on the first anniversary of the day on which it receives the Royal Assent.

Note

The repeal of this Act does not affect the repeals made by it (see section 15(1) of the **Interpretation of Legislation Act 1984**).
