ELECTRICITY INDUSTRY AMENDMENT (PREMIUM SOLAR FEED-IN TARIFF) BILL 2009

(Suggested amendments to be proposed in Committee by Mr BARBER in substitution for amendments previously circulated)

That it be a suggestion to the Assembly that they make the following amendments in the Bill:

- 1. Clause 4, page 2, line 14, omit "40FE" and insert "40FD".
- 2. Clause 4, page 3, lines 19 and 20 omit all words and expressions on these lines and insert—

"premium solar feed-in payment has the meaning given by section 40FA(1);".

- 3. Clause 4, page 3, line 27, omit "40FF, 40FG" and insert "40FE, 40FF".
- 4. Clause 4, page 4, lines 6 and 7, omit "as their principal place of residence".
- 5. Clause 4, page 4, line 17, omit "3·2" and insert "10".
