

## LEGISLATIVE COUNCIL

JUSTICE LEGISLATION FURTHER AMENDMENT (MISCELLANEOUS) BILL  
2025(Amendments and New Clauses to be proposed in Committee by SARAH MANSFIELD)

1. Clause 1, page 3, line 15, omit "Court." and insert "Court;".
2. Clause 1, page 3, after line 15 insert—
  - "(ha) to amend the **Independent Broad-based Anti-corruption Commission Act 2011**—
    - (i) to expand the jurisdiction of the Independent Broad-based Anti-corruption Commission by amending the definition of *corrupt conduct*; and
    - (ii) to provide for the investigation of conduct occurring before the commencement of this Act; and
    - (iii) to make consequential amendments."

## NEW CLAUSES

3. Insert the following New Part to follow Part 8—

**'Part 8AAAA—Amendment of Independent Broad-based Anti-corruption Commission Act 2011****76AAAA Definitions**

In section 3(1) of the **Independent Broad-based Anti-corruption Commission Act 2011**, the definition of *relevant offence* is repealed.

**76AAAB Corrupt conduct**

- (1) In section 4(1) of the **Independent Broad-based Anti-corruption Commission Act 2011**—
  - (a) in paragraph (e), for "or (da)—" substitute "or (da).";
  - (b) omit "being conduct that would constitute a relevant offence."
- (2) Section 4(1A) of the **Independent Broad-based Anti-corruption Commission Act 2011** is repealed.

**76AAAC Conduct occurring before the commencement of this section**

At the end of section 11 of the **Independent Broad-based Anti-corruption Commission Act 2011** insert—

"(2) This Act as amended by the **Justice Legislation Further Amendment (Miscellaneous) Act 2025** applies to and in respect of conduct all or part of which occurred before the commencement of this subsection if the conduct would have been corrupt conduct within the meaning of this Act as amended by the **Justice Legislation Further Amendment (Miscellaneous) Act 2025** had this subsection been in force at the time the conduct occurred."

**76AAAD Determination of matter previously considered by the IBAC**

At the end of section 11A of the **Independent Broad-based Anti-corruption Commission Act 2011** insert—

"(2) The IBAC may determine to investigate any complaint or notification to the IBAC that the IBAC has before the commencement of section 76AAAD of the **Justice Legislation Further Amendment (Miscellaneous) Act 2025**—

- (a) dismissed under section 58(a); or
- (b) referred to a person or body (other than the Ombudsman) under section 73; or
- (c) referred to the Ombudsman under section 73 and the Ombudsman has dismissed it or has determined not to investigate it."!
