# FREEDOM OF INFORMATION AMENDMENT (FREEDOM OF INFORMATION COMMISSIONER) BILL 2011

(Suggested amendments to be proposed in Committee by Mr Barber)

That it be a suggestion to the Assembly that they make the following amendments in the Bill:

1. Page 54, after line 1 insert the following heading—

"Division 1—Alcoa (Portland Aluminium Smelter) (Amendment) Act 1984".

## **NEW CLAUSE**

2. Insert the following New Clause to follow the heading proposed by amendment number 1—

## "A Section 14 repealed

Section 14 of the **Alcoa (Portland Aluminium Smelter) (Amendment) Act 1984** is **repealed**.".

3. Page 54, before line 2 insert the following heading—

"Division 2—Australian Grands Prix Act 1994".

4. Insert the following New Clause to follow the heading proposed by amendment number 3—

### **'B Freedom of Information Act 1982**

(1) For the heading to section 49 of the **Australian Grands Prix Act 1994** substitute—

## "Financial Management Act 1994."

- (2) In section 49(1) of the **Australian Grands Prix Act 1994**, for "Despite anything to the contrary in the **Freedom of Information Act 1982**, that Act does not apply to a document, whether created before, on or after the commencement of this section, to the extent that the document is, or discloses information about" **substitute** "This section applies to".'.

Section 114 of the Firearms Act 1996 is repealed.".

- 9. Page 56, after line 12 insert the following heading—

## "Division 6—Loy Yang B Act 1992".

### **NEW CLAUSE**

10. Insert the following New Clause to follow clause 42 and the heading proposed by amendment number 9—

## "D Section 34 repealed

Section 34 of the Loy Yang B Act 1992 is repealed.".

- 11. Division heading preceding clause 43, omit "3" and insert "7".
- 12. Division heading preceding clause 48, omit "4" and insert "8".
- 13. Division heading preceding clause 50, omit "5" and insert "9".
- 14. Page 61, after line 6 insert the following heading—

## "Division 10—Treasury Corporation of Victoria Act 1992".

### **NEW CLAUSE**

15. Insert the following New Clause to follow clause 51 and the heading proposed by amendment number 14—

## "E Section 40 repealed

Section 40 of the **Treasury Corporation of Victoria Act 1992** is **repealed**.".

- 16. Division heading preceding clause 52, omit "6" and insert "11".
- 17. Page 61, after line 16 insert the following heading—

## "Division 12—Victorian Funds Management Corporation Act 1994".

## **NEW CLAUSE**

18. Insert the following New Clause to follow clause 51 and the heading proposed by amendment number 17—

### "F Section 39 repealed

Section 39 of the **Victorian Funds Management Corporation Act 1994** is **repealed**.".
