4. Insert the following New Clause to follow clause 9—

'A Section 97A substituted

For section 97A of the **Planning and Environment Act 1987** substitute—

"97A Definitions

In this Division—

ongoing responsible authority has the meaning set out in section 97H(4);

referring responsible authority means the responsible authority that referred an application to the Minister under section 97B or 97C.". '.

- 8. Clause 12, lines 4 and 5, omit "responsible authority specified in the planning scheme" and insert "ongoing responsible authority".
- 9. Clause 13, after line 6 insert—
 - '() In section 97H of the **Planning and Environment Act 1987**, for "Once" **substitute** "Subject to subsections (2) and (3), once". '.
- 10. Clause 13, line 7, before "In section" insert "(2)".
- 11. Clause 13, after line 10 insert—
 - '() At the end of section 97H of the **Planning and Environment Act 1987**insert—

- "(2) If at the time of the grant of the permit, the responsible authority specified in the planning scheme is not the same person as the referring responsible authority, the responsible authority specified in the planning scheme does not become the responsible authority for the administration and enforcement of this Act and the relevant planning scheme in respect of the permit (whether or not the permit is amended) under subsection (1) unless it consents to becoming the responsible authority for those purposes.
- (3) If the responsible authority specified in the planning scheme does not give consent under subsection (2), the referring responsible authority becomes the responsible authority for the administration and enforcement of this Act and the relevant planning scheme in respect of the permit (whether or not the permit is amended) under subsection (1).
- (4) The person that is to be the responsible authority for the administration and enforcement of this Act and the relevant planning scheme in respect of the permit (whether or not the permit is amended) under subsection (1), except for the matters in respect of which the Minister remains the responsible authority for the permit under that subsection, is the *ongoing responsible authority*.".'.

- 13. Clause 15, lines 19 and 20, omit" responsible authority specified in the planning scheme" and insert "ongoing responsible authority".
